# **JK Global Opportunities Fund**

## May 2020

USD Class +2.16%, GBP Class +2.13%, YEN Class +2.17%, EUR Class +2.05% in May.

The Fund rose +2.16% (USD Class, net of fees) in May, as solid gains from our US and Japanese equities more than offset the small losses in our China book. A notable contribution came from our long position in a Nikkei dividend future, as markets continue to reprice the low risk event that cash-rich corporates cut their dividends in Japan next year. Another stand-out performer was ACM Research, which we view as being a key beneficiary to the localisation of China's semiconductor industry. We also initiated a long position in Eurostoxx futures towards the end of the month as a rotation into value began to take hold, which is contributing meaningfully to returns this month.

May saw risk assets continue their march higher despite some concerning developments in the geopolitical sphere. In particular, US-China tensions came to the boil once again, manifesting themselves in so many different guises that it is becoming difficult to keep track of all the moving parts, let alone what their implications for markets might be. In retaliation for China's perceived mishandling of the coronavirus, the US has made capital market access and intellectual property the key battlegrounds of renewed disputes, whilst China has made a power grab for Hong Kong after imposing a national security law into their mini constitution. We are reluctant to make too many prognostications as to how all this plays out, but for now have reduced exposures to variable interest entities (VIEs) listed in Hong Kong and the US (ADRs) whilst we reassess the risks from investing in these structures. For the time being, at least, both sides seem to be avoiding worst-case scenarios, which is encouraging.

The resilience of markets in the face of all this uncertainty is adding to already high levels of confusion within the investment community. The post-fact narrative ascribes this resilience to the steady reopening of economies, which whilst might have some truth in it, is hardly 'new news' and not enough to explain why markets are willing to look through so much negativity in our view. We believe this story is incomplete and still shows an underappreciation for the significant easing in financial conditions resulting from central bank liquidity and ongoing fiscal largesse.

In China, credit generation has quickly accelerated to 28% of GDP, the highest in two years, and we estimate that the fiscal and credit impulse will soon exceed 14%, putting this policy cycle on par with the 2012-13 cycle. Ever-expanding quotas for local government special bonds to CNY3.75trn (~US\$500bn) will also ensure that infrastructure spending energises any recovery. Elsewhere, Korea and Japan announced more stimulus measures last month and the US is debating adding another round of fiscal spending. Even Europe seems to be moving in the right direction, as combined public deficits look set to reach 8.5% of GDP, although we note that this is heavily skewed towards Germany and have reservations about the 'Recovery Fund' being a game-changing 'Hamiltonian' moment for full federalisation. Meanwhile, the ECB's balance sheet is swelling more quickly than during either the GFC or the euro area crisis.

Another reason we believe markets continue to 'climb the wall of worry' is because positioning and sentiment are still cautious, having come from such a low starting point. This corroborates with evidence we are seeing from numerous investor surveys. Valuation concerns are now being added to

lingering coronavirus and geopolitical worries as reasons to keep investors on the sidelines, which means there is still a wall of cash waiting to come into markets. However, as mentioned in previous notes, we believe painting stocks with the broad brush of market-wide valuation metrics has become slightly irrelevant in the current climate given the divergence in individual stock and sector prospects, and therefore doesn't fit with our preferred strategy of picking quality companies. In any case, adjusting P/E ratios for negative real rates and abundant liquidity provisions makes us more sanguine about valuations than the consensus, which continues to inform our pro-risk bias.

The caveat to this would obviously be if there was an accident in bond markets, which would make current valuations far more demanding. We are currently exploring some volatility-based hedges to remove this tail-risk, but for now, as long as financial conditions remain easy and sentiment stays bearish, conditions are ideal for risk assets on a medium-term view. We are positioned accordingly.
